## Classes of Membership

- **JUNIOR MEMBERS:** A person is eligible to become a **Junior Member** of the Association if he/she is under the age of 18 years and has passed the Preliminary Test of Ice Skating Australia Incorporated or its equivalent.
- **CADET MEMBERS:** A person is eligible to become a **Cadet Member** of the Association if he/she is under the age of 18 years and has not passed a Preliminary Test of Ice Skating Australia Incorporated or its equivalent.
- **SENIOR MEMBERS:** A person is eligible to become a **Senior Member** of the Association if he/she is aged 18 years or over, and:
  - Has passed a Preliminary Test of Ice Skating Australia or its equivalent as determined by Ice Skating Australia Incorporated procedures for overseas skaters; or
  - Is the parent of a current Junior Member who has passed a Preliminary Test of Ice Skating Australia or its equivalent; or
- **ASSOCIATE MEMBERS:** A person is eligible to become an **Associate Member** of the Association if he/she is aged 18 years or over and:
  - is a candidate for the Preliminary Test of Ice Skating Australia Incorporated.
  - seeks to enter Association competitions or championships which do not require a test entry qualification
  - is a member of an ISQ Affiliated Club
- **SOCIAL MEMBER – SKATING:** A person is eligible to become a **Social – Skating Member** of the Association if he/she is aged 18 years or over and is not eligible to become a Senior Member or Associate Member, but supports the Primary Object of the Association and wishes to use the ice rink facility for skating and has not passed a Preliminary Test of Ice Skating Australia.
- **SOCIAL MEMBER – NON SKATING:** A person is eligible to become a **Social- Non Skating Member** of the Association if he/she is aged 18 years or over and is not eligible to become a Senior Member or Associate Member, but supports the Primary Object of the Association.
